**ORDER AMENDING CERTIFICATE OF PUBLIC GOOD
TO REFLECT NAME CHANGE**

I. INTRODUCTION

On September 18, 2002, Associated Network Partners, Inc. (the "Company" or "Petitioner"), received a Certificate of Public Good (CPG No. 710-R), pursuant to 30 V.S.A. § 231, to provide telecommunications services in Vermont.

On December 6, 2013, the Company filed a petition ("Petition") with the Vermont Public Service Board ("Board") requesting that its CPG be amended to reflect a corporate name change to ANPI, LLC. As part of its Petition, the Company also filed a Certificate of Organization from the Vermont Secretary of State for ANPI, LLC.

On December 16, 2013, the Vermont Department of Public Service ("Department") filed a letter with the Board in support of the Company's request.

The Board, having reviewed the Company's Petition and the other materials it filed, agrees that an amended CPG should be issued. As a result, newspaper publication is not required prior to issuance of the amended CPG. 30 V.S.A. §§ 102(a), 231(a).

Based upon the Company's Petition and accompanying documents, the Board makes the following findings.

II. FINDINGS

1. The Company was issued CPG No. 710-R on September 18, 2002, to provide telecommunications services in Vermont. *See* CPG No. 910-R.

2. As of December 6, 2013, the Company had received and filed with the Board all documents necessary to effect a name change to ANPI, LLC. Petition and Attachments.

III. DISCUSSION

30 V.S.A. § 231(a) provides that the Board may amend or revoke any CPG for good cause, after an opportunity for hearing. Since there is no controversy surrounding the Company's name change, it follows that good cause exists to amend the Company's CPG to reflect the new name of the holder of the certificate. As for whether a hearing is necessary, we conclude that it is not. First, there is no genuine issue of material fact as to whether the Company's CPG should be amended and, consequently, under V.R.C.P. 56, a hearing is unnecessary. Second, the Petitioner has asked that the CPG be amended, and the DPS has recommended that the Petition be approved without hearing. Finally, 30 V.S.A. § 231(a) requires only the opportunity for a hearing, thus acknowledging that a hearing is not always necessary prior to amendment.

IV. CONCLUSIONS

1. The CPG held by Associated Network Partners, Inc. should be amended to reflect the new name of the certificate-holder: ANPI, LLC.

V. ORDER

IT IS HEREBY ORDERED, ADJUDGED AND DECREED by the Public Service Board of the State of Vermont that:

1. The Certificate of Public Good that was issued to Associated Network Partners, Inc. on September 18, 2002, shall be amended to reflect the new name of the holder of the certificate: ANPI, LLC.
