**ORDER AMENDING CERTIFICATE OF PUBLIC GOOD  
TO REFLECT NAME CHANGE**

**I. INTRODUCTION**

On November 8, 1994, in Docket No. 5741, Frontier Communications International, Inc. ("Frontier" or "the Company") received a Certificate of Public Good ("CPG"), pursuant to 30 V.S.A. § 231, to provide resold intrastate telecommunications services throughout Vermont under the name of RCI Long Distance, Inc. On January 23, 1995, in Docket No. 5791, the Board approved a name change from RCI Long Distance, Inc. to Frontier Communications, Inc. On September 7, 2000, Frontier filed a petition with the Board requesting that its CPG be amended to reflect a change in corporate name from Frontier to Global Crossing North American Networks, Inc. As part of its petition, the Company also filed an amended certificate of authority to conduct business in Vermont as a foreign corporation as Global Crossing North American, Inc.

On October 30, 2000, the Vermont Department of Public Service ("Department") filed a letter with the Board recommending that the Board approve the Company's request. The Department noted that the name change does not appear to change the management structure, nor does it result in rate changes. Further, the Department recommended that the Board approve the petition without the need for hearings or investigation.

The Board, having reviewed the Company's petition and the other materials it filed, agrees that an amended CPG should be issued. As a result, newspaper publication is not required prior to issuance of the amended CPG. 30 V.S.A. §§ 102(a), 231(a).

Based upon the Company's petition and accompanying documents, the Board makes the following findings.

## II. FINDINGS

1. Frontier, a Delaware corporation, was issued a CPG to provide telecommunications services in Vermont on November 8, 1994, under the name RCI Long Distance, Inc. Petition at 2.
2. A name change from RCI Long Distance, Inc. to Frontier was approved by the Board in Docket No. 5791 on January 23, 1995. Petition at 2.
3. As of September 7, 2000, the Company had received and filed with the Board all documents necessary to effect a corporate name change. Petition at 2 and Exhibit 1.
4. The proposed name change does not involve any change in ownership or the business practices of the Company, nor will it have any impact upon the services provided to the Company's customers. Petition at 2.

## III. DISCUSSION

30 V.S.A. § 231(a) provides that the Board may amend or revoke any CPG for good cause, after an opportunity for hearing. Since there is no controversy surrounding the Company's name change, it follows that good cause exists to amend the Company's CPG to reflect the new name of the holder of the certificate. As for whether a hearing is necessary, we conclude that it is not. First, there is no genuine issue of material fact as to whether the Company's CPG should be amended and, consequently, under V.R.C.P. 56, a hearing is unnecessary. Second, the petitioner has asked that the CPG be amended, and the DPS has recommended that the petition be approved without hearing. Finally, 30 V.S.A. § 231(a) requires only the opportunity for a hearing, thus acknowledging that a hearing is not always necessary prior to amendment.

## IV. CONCLUSIONS

1. The CPG held by Frontier Communications International, Inc. should be amended to reflect the new name of the certificate-holder: Global Crossing North American Networks, Inc. 30 V.S.A. § 231.
2. The Company should file an amended tariff with the Board that reflects the Company's new name, within 30 days of issuance of its amended CPG.

V. ORDER

IT IS HEREBY ORDERED, ADJUDGED AND DECREED by the Public Service Board of the State of Vermont that:

1. The Certificate of Public Good that was issued to Frontier Communications International, Inc. on November 8, 1994, and later amended on January 23, 1995, shall be amended to reflect the new name of the holder of the certificate: Global Crossing North American Networks, Inc.

2. The Company shall file an amended tariff with the Board that reflects the Company's new name, within 30 days of issuance of its amended CPG.
