AMENDED CERTIFICATE OF PUBLIC GOOD ISSUED
PURSUANT TO 30 V.S.A. SECTION 231

IT IS HEREBY CERTIFIED that the Public Service Board of the State of Vermont on this date finds and adjudges that the Certificate of Public Good issued to Tel-Save, Inc. d/b/a Network Services of New Hope on December 18, 1995, and subsequently amended on February 10, 2000, to reflect a name change to Talk.Com Holding Corp. d/b/a Network Services of New Hope also d/b/a TPC of New Hope, pursuant to 30 V.S.A. § 231, is further amended to reflect the new name of the holder of the certificate: Talk America, Inc. ("the Company"). This Certificate shall be subject to any and all conditions or restrictions contained in its original CPG, in addition to the following conditions:

1. The Company is subject to the provisions of Title 30, V.S.A., to the same extent as other regulated utilities.
2. This Certificate may not be transferred to any other party without prior approval by the Public Service Board.
3. If the Company intends to do business in the State of Vermont under any trade name other than the name in use on the date of the Order in this Docket, it shall file a notice of the new trade name with the Clerk of the Board and the Department of Public Service fifteen (15) days prior to commencing business under the new name.¹
4. The Company shall be subject to any rules lawfully adopted or to be adopted by the Board, and its Certificate hereby incorporates those rules by reference. The Company's Certificate shall be

subject to revocation upon good cause, including a substantial or continuous failure to abide by its material terms.
